<p>By this agreement made between the above named employee ("the Participant") and the University of Southern California ("the University"), the parties hereto agree as follows:</p> <p>Effective with respect to amounts paid on or otherwise made available on or after January 2020, which date is subsequent to the last day of the month in which this Agreement is executed, the Participant has elected to defer the amount indicated from his/her salary. At the same time, the University will contribute a corresponding amount to the University of Southern California Section 457(b) Plan for Eligible Faculty and Administrative Staff (the "Plan") and the Participant may direct the investment of such amount among the funds approved by the University. This agreement shall be legally binding and irrevocable with respect to amounts paid or otherwise made available while this Agreement is in effect, except that the University may reduce the amount deferred if it determines that such amount exceeds the applicable limitations of the Plan and Code Section 457. This Agreement may be changed or revoked at any time, effective for the calendar month following the month in which such change or revocation occurs. In no case will the Agreement result in deferral of salary which will cause the contribution to the Participant's account to exceed the applicable limits of Internal Revenue Code Section 457(b).
